

DAVIS FORD CROSSING HOLIDAY SHOPPING SPREE DRAWING

Official Rules & Regulations

PROGRAM DATES

Davis Ford Crossing Holiday Shopping Spree Drawing will begin on November 8, 2011 and end at 10 a.m. on December 12, 2011. Drawing will take place on or about December 13, 2011.

ELIGIBILITY

No age requirement. Minors must obtain parent's permission to participate by providing their parent's home phone number and/or valid email address. All employees and families of Davis Ford Crossing stores and The Rappaport Companies are not eligible. Prior winners of Davis Ford Crossing contests are not eligible to win more than once in a calendar year.

RANDOM DRAWING
