



Springfield Plaza Think Green This Spring Shopping Spree Official Rules & Regulations

Program Dates

Springfield Plaza Think Green This Spring Shopping Spree Contest will begin on Wednesday, March 24, 2010 and end 10 a.m. on April 13, 2010. Drawing will take place on or about April 14, 2010.

Eligibility

No age requirement. Minors must obtain parent's permission to participate by providing their parent's home phone number and/or valid email address. All employees and their families of Springfield Plaza stores and The Rappaport Companies are not eligible. Prior winners of Springfield Plaza contests are not eligible to win more than once in a calendar year.

Random Drawing

Potential winners will be selected in a random drawing on or about April 14, 2010 from among all eligible entries received by Springfield Plaza. Odds of winning are determined by number of entries.
