

VIENNA SHOPPING CENTER HOLIDAY SHOPPING SPREE DRAWING

Official Rules & Regulations

PROGRAM DATES

Vienna Shopping Center Holiday Shopping Spree Drawing will begin on November 4, 2011 and end at 10 a.m. on December 5, 2011. Drawing will take place on or about December 6, 2011.

ELIGIBILITY

No age requirement. Minors must obtain parent's permission to participate by providing their parent's home phone number and/or valid email address. All employees and families of Vienna Shopping Center stores and The Rappaport Companies are not eligible. Prior winners of Vienna Shopping Center contests are not eligible to win more than once in a calendar year.

RANDOM DRAWING

Potential winner will be selected in a random drawing on or about December 6, 2011 from among all eligible entries received by Vienna Shopping Center. Odds of winning are determined by number of entries.
